ILA RELEASES ADVOCACY MANUAL ON PROTECTING CHILDREN'S RIGHTS TO READ

Global organization empowers educators and community members to take action

Newark, Del. (May 21, 2019) — The International Literacy Association (ILA) today published an advocacy manual to guide literacy partners in protecting children's rights to read.

The manual is an extension of the campaign ILA began last September, which launched with the goal of ensuring every child, everywhere, has access to the education, opportunities and resources needed to read. The initiative is based on 10 fundamental rights ILA asserts that every child deserves, such as "the right to read for pleasure."

In addition to teachers and reading/literacy specialists, the manual addresses administrators, librarians, families and policymakers. It includes a questionnaire to help readers critically examine their own and their community's literacy practices, targeted action items for each audience and concrete steps they can take to accomplish those goals.

ILA Executive Director Marcie Craig Post says she hopes the guide will empower literacy stakeholders to come together and mobilize in support of the rights.

"Since we launched the campaign last September, we've seen a deluge of support in the form of thousands of signatures and social media shares. The next step is to propel that support into action," she says. "This guide will help visualize what the rights look like in practice and bring that vision to life."
