## Texas A&M's R. Malatesha Joshi Receives ILA's Highest Honor

NEWARK, DE | July 1, 2025—The International Literacy Association (ILA) has named R. Malatesha Joshi, professor at Texas A&M University, as the recipient of its 2025 **William S. Gray Citation of Merit,** the Association's highest individual honor. The award recognizes Joshi's lifelong contributions to literacy research, leadership, and advocacy on an international scale.

Joshi is among the following distinguished educators and researchers recognized through ILA's 2025 Awards and Grants program, which celebrates innovation, service, and scholarly excellence in the field of literacy. The 2025 cycle also marks the revival of ILA's **International Citation of Merit**, last awarded in 2014, and the debut of the **Carrice Cummins Outstanding Preservice Educator Award**, named in honor of the former ILA president and longtime literacy advocate.

Douglas Fisher, another past president of ILA, and longtime collaborator Nancy Frey, received this year's **Diane Lapp & James Flood Professional Collaborator Award** in recognition of their joint contributions to the field.
